**RECORD OF : Minutes of Proceeding**

Court heard re: Superseding Indictment. Court directed the government to file the next Superseding Indictment promptly.

Indictment read in open court. Defendants advised of rights. Not guilty pleas entered as to defendants Ammon Bundy, Jon Ritzheimer, Joseph O'Shaughnessy, Ryan Payne, Ryan Bundy, Brian Cavalier, Shawna Cox, Peter Santilli, Jason Patrick, Duane Leo Ehmer, Dylan Anderson, Kenneth Medenbach. Merits of whether to declare the case "complex" will be heard at the next monthly Status Conference set for March 9, 2016, beginning at 9:00 A.M.. Jury Trial (4 weeks) SET for April 19, 2016 at 9:00 A.M. in Courtroom 14A before Judge Anna J. Brown remains as previously set for each Defendant, and as to Defendants whose first appearance was February 24, 2016 the Court sets the same jury trial date subject to further review on March 9, 2016.

Court directed counsel to confer and to include in the Joint Status Report to be filed on March 7, 2016, a single joint statement of the current outside trial date as to each Defendant in this matter and in 3:16-cr-00064-JO.

Court heard and addressed Motion for Hearing re: Discovery Management, Preservation of Evidence and for Provision of Defense Access to Crime Scenes (#141) and Motion to Compel Preservation of Evidence (#144). Government stated the site would be made available February 25 and 26, 2016, and, therefore, the Court concludes Motions #141 and #144 are moot. Defendants have leave to renew their arguments with respect to preservation of evidence and the like in due course.

Monthly Status Conferences will be held the first Wednesday of every month except for the month of March 2016 when the conference will be held on March 9, 2016 at 9:00 A.M. in Courtroom 14A. Court directed the Clerk also to arrange for all in-custody Defendants in 3:16-cr-00064-JO to be transported for this hearing unless a Waiver of Appearance signed by the Defendant has been filed. Defendants who wish to waive their appearance for the March 9, 2016, hearing will need to sign and to file the Waiver of Appearance no later than February 26, 2016, by NOON. Joint Status Report is due no later than March 7, 2016, by NOON to prepare the Court for the monthly status hearing.

Oral request of Ammon Bundy to attend site visit February 25, 2016, denied.

Court scheduled Defendant Santilli's Motion for Hearing to Reopen and to Review Detention (#187) for Monday, February 29, 2016, at 3:00 P.M. in Courtroom 14A before Judge Anna J. Brown.

Defendant Kenneth Medenbach stated he had a Motion to Dismiss that needed to be filed. Court directed his standby counsel to assist Defendant Medenbach with filing the Motion in the record. Court directed that if Defendant Medenbach seeks to represent himself, he should also file a Motion for Faretta Hearing. Defendant Medenbach may also file a Motion for Review of Detention. The Court will set a hearing on any such motions when they are filed.

Court directed government counsel to provide as much discovery as feasible to defense counsel no later than noon on March 4, 2016.
