**SUPERSEDING INDICTMENT**

The Grand Jury charges that:

**COUNT 1**  
**(Possession of an Unregistered Firearm)**

On or about November 22, 2015, in Snohomish County, within the Western District of Washington, SCHUYLER PYATTE BARBEAU knowingly possessed a firearm which was not registered to him in the National Firearms Registration and Transfer Record, as required by law, namely, a particular black, fully-automatic AR-15 5.56mm caliber assault rifle with a 10.5 inch barrel, a holographic sight, and a drop-in auto sear, a rifle having a barrel of less than 16 inches in length and a fully automatic

1 machinegun.

2 All in violation of Title 26, United States Code, Sections 5861(d) and 5845(a)(3)  
3 and (6).

4 **COUNT 2**  
5 **(Possession of a Machinegun)**

6 On or about November 22, 2015, in Snohomish County, within the Western  
7 District of Washington, SCHUYLER PYATTE BARBEAU did knowingly possess and  
8 transfer a machinegun, that is, a particular black, fully-automatic AR-15 5.56mm caliber  
9 assault rifle with a 10.5 inch barrel, a holographic sight, and a drop-in auto sear.

10 All in violation of Title 18, United States Code, Sections 922(o) and 924(a)(2).

11 **ASSET FORFEITURE ALLEGATION**

12 Upon conviction of the offenses alleged in the Superseding Indictment,


